## Clinical Evaluation Services and Fee Agreement

This document includes your Agreement Form and descriptions of services to help determine what type of testing would be most useful. Your doctor can recommend which tests and/ or add on testing packages will best answer your test questions. Surveys and measures will be tailored to your testing needs. Specific tests and measures listed in the packages below are common components offered with the package and are not a complete list of options. Your doctor may choose to include more or fewer assessment measures depending on the goals of testing. Please note a NONREFUNDABLE deposit equal to half of the testing cost is required to schedule all evaluations (with the remaining balance due the first day of testing). Results are typically available about three weeks from either the last date of testing or when all parent/teacher/rating forms are received, whichever occurs later.

### Psychoeducational /Educational /Academic Evaluations

**Full Psychoeducational Evaluation:** Ages 4+. This includes an IQ and Achievement battery plus AD/HD testing to assess for the possibilities of AD/HD and/ or learning disabilities, combined with diagnostic interviewing to screen for the influence of depression, anxiety, and other mental health conditions on educational abilities and performance. A complete history is also taken during the parent interview to identify any social, emotional, behavioral, psychological, or medical concerns that might be affecting educational abilities and performance. The evaluation is broken down into at least two sessions to avoid fatigue for the client and thus result in the clearest diagnostic results.

\*Some packages can be expanded to include additional measures, extended record review, etc. and will be billed at the provider's hourly rate.

**Tests:** IQ/ Cognitive Assessment (WPPSI, WISC, WAIS, or Stanford Binet depending on age)

Achievement Test (Woodcock-Johnson IV/ WJ-IV, TEMA, TERA)

Play-based assessment/ child interview/ self-report surveys (age dependent)

Parent & teacher surveys (e.g., BASC-3, BRIEF-2, ADHD-RS-5 or Vanderbilt)

**Time\*** - In addition to the 1 hr separate parent interview conducted prior to the selection of this testing package:

5 - 6 hours with the client (testing divided into at least 2 sessions).

Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed) 1-hour feedback session

**Cost:** \$2400\*

**IQ & Achievement Evaluation (Gifted Evaluation/LD Evaluation/Dyslexia Evaluation):** Ages 2+. These IQ and Achievement tests will provide in-depth information on several factors of intelligence (such as factual knowledge, short-term memory, abstract reasoning, visual-spatial abilities, and common sense), academic strengths and weaknesses, mastery of specific subjects, and the presence of a learning disability. The results are commonly used by many educational programs to determine if a child meets criteria for a "Gifted" or "Learning Disabled" classification.

**Tests:** IQ/ Cognitive Assessment (WPPSI, WISC, or WAIS depending on age)

Achievement Test (Woodcock-Johnson IV/ WJ-IV)

**Time\*** - In addition to the 1 hr separate parent interview conducted prior to the selection of this testing package:

4 - 5 hours (testing divided into 2 sessions)

Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed) 1-hour feedback session

**Cost for Ages 2-5:** \$995

**Cost for Ages 6+:** \$1,350

**Full Neuropsychological Evaluation:** Ages 4+. This includes our Full Psychoeducational Evaluation as well as comprehensive memory and language testing. Memory testing assesses visual and auditory short-term and long-term memory, which is valuable in identifying a student's ideal learning style and problems with the retention of academic material. Language testing assesses expressive and receptive language, as well as overall language ability, which is helpful when there are subtle problems with a child's learning or performance in school over time, or when a student has a history of struggles in reading or writing. A screening for behavioral, social, and emotional issues is also provided.

**Tests:** IQ/ Cognitive Assessment (WPPSI, WISC, or WAIS depending on age)

**Achievement Test (Woodcock-Johnson IV/ WJ-IV)**

**Children's Memory Scale (CMS) or Wechsler Memory Scale (WMS)**

**Play-based assessment/ child interview/ self-report surveys)**

**Parent & Teacher surveys (e.g., BASC-3, BRIEF-2, ADHD-RS-5 or Vanderbilt, or others)**

**Time\*** - In addition to the 1 hr separate parent interview conducted prior to the selection of this testing package:

**6 – 8 hours (testing divided into 3 sessions)**

**Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed)**

**1-hour feedback session**

**Cost: \$2850\***

**Early Entrance to Kindergarten Evaluation:** Ages 4 & 5. This includes intellectual (aptitude) and achievement testing (reading and math) to help determine if your child meets the cognitive and academic requirements for early entry. Please note this testing does not include writing.

**Tests:** IQ/ Cognitive Assessment (Wechsler Preschool and Primary Scale of Intelligence/ WPPSI) Woodcock Johnson IV (WJ-IV)

**Time:** 2 hours testing, including a brief parent interview

**30-minute feedback session**

**Cost: \$750**

**Kindergarten Readiness Evaluation:** For children who will be five, but parents aren't sure if they should start kindergarten or wait another year. In addition to testing, we informally assess attention and behavioral, social and emotional functioning. This provides a full assessment of your child's readiness for kindergarten, and we can discuss what types of school settings may be a good fit.

**Tests:** IQ/ Cognitive Assessment (Wechsler Preschool and Primary Scale of Intelligence/ WPPSI)

**Woodcock Johnson IV (WJ-IV)**

**Play-based assessment/ child interview**

**Parent & Teacher surveys (e.g., BASC-3)**

**Time:** 3 hours testing, including a brief parent interview

**1-hour feedback session**

**Cost: \$950**

**Cognitive (IQ) Evaluation only: Ages infants+** This typically includes the Wechsler Intelligence Test (WISC) or Stanford Binet, which provide in-depth information on several factors of intelligence (i.e. factual knowledge, short-term memory, abstract reasoning, visual-spatial abilities, common sense, etc.), and on academic strengths and weaknesses. The results are used by educational programs as part of the determination of the "Gifted" label. At the other end of the spectrum, the results can also identify intellectual disability.

**Test:** Wechsler Intelligence Scales (WPPSI, WISC, or WAIS, depending on age) or

**The Stanford-Binet Intelligence Scales (SB-5) or**

**Test of Nonverbal Intelligence, Fourth Edition (TONI-IV)**

**Time:** 1.5 - 2 hours testing, including 20 – 30 minutes for a parent or clinical interview

**Interpretive session not included, may be scheduled separately**

**Cost: \$550**

**Achievement Evaluation only:** This typically includes the Woodcock-Johnson IV (WJ-IV), the standard in assessing academic achievement, which will provide in-depth information regarding a child's mastery of specific subjects, academic strengths, and weaknesses.

**Tests:** Woodcock-Johnson IV (WJ-IV) *or*  
TEMA (Test of Early Mathematics Ability) and TERA (Test of Early Reading Ability) *or*  
Wechsler Individual Achievement Test (WIAT-III)  
**Time:** 2 - 3 hours, which could include 20 – 30 minutes for a parent or clinical interview  
Interpretive session not included, may be scheduled separately  
**Cost:** \$550

**AD/HD Evaluation:** Ages 3-22. This includes AD/HD testing combined with a full IQ test, clinical interviewing, rating scales, and play-based assessment for younger children.

**Tests:** IQ/ Cognitive Assessment (WPPSI, WISC, or WAIS depending on age)  
Play-based assessment/ child interview/ self-report surveys  
Parent & Teacher surveys (e.g., BASC-3, BRIEF-2, ADHD-RS-5 or Vanderbilt)  
CPT available as an additional fee if required.  
**Time\*** - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of this testing package:  
3 - 4 hours testing  
Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed)  
1-hour feedback session  
**Cost:** \$1150. Additional fees apply if a CPT is needed.

**Adult AD/HD Evaluation:** Ages 23+. This includes AD/HD testing, a full IQ test, clinical interviewing, and rating scales.

**Tests:** IQ/ Cognitive Assessment (WAIS)  
Clinical Interview, Option for Parent/ Collateral Interviews as well  
Self-Report Surveys (e.g., PAI, BRIEF-A, BDI-II, BAI)  
Parent/ Teacher/ Other surveys  
**Time\*** - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of the testing package:  
3 - 4 hours testing  
Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed)  
1-hour feedback session  
**Cost:** \$1495. Additional fees apply if a CPT is needed.

**Comprehensive Memory Evaluation:** Memory testing provides specific information about a child's auditory/ verbal and visual/nonverbal memory, as well as attention and concentration.

**Tests:** Children's Memory Scale (CMS) or Wechsler Memory Scale (WMS)  
**Time:** Typically, 2 - 2.5 hours total  
**Cost:** \$550

**Language Evaluation:** Language testing

**Tests:** Clinical Evaluation of Language Fundamentals (CELF)  
**Time:** Typically, 2 hours total  
**Cost:** \$550

**School Consultation/Observation:** School consultations are designed to assist in identifying a child's educational and behavioral needs at school and developing and implementing a plan to meet those needs. We may observe your child at school and talk with his teacher to assess concerns and discuss classroom interventions & accommodations. We can attend formal meetings with parents at their child's school (such as IEP or 504 meetings). You and your child may also attend sessions at our office focused on study and organizational skills and developing a homework contract. (Please note there is no CPT code for school visits, which means your insurance company may not reimburse for these services, depending on your plan.)

**Time:** Typically, 1 hour is spent at the school, 1 hour for report writing, plus drive time.  
**Cost:** Clinician's hourly rate (ranging from \$160 - \$265), including driving time to and from the office

## Psychological Evaluations (Used when the question is primarily psychological or developmental.)

**Developmental Evaluation / Autism Evaluation:** Ages 18 months+. This is a battery of tests and interviews for clients when there are concerns about cognitive, social, emotional, or behavioral development. An IQ test is included in this package. This evaluation can also be used when parents want to determine if their child has a disorder on the Autistic Spectrum.

**Tests:** IQ/ Cognitive Assessment (Bayley-4, WPPSI, WISC, or WAIS depending on age)

Play-based assessment/ child interview/ self-report surveys

Parent & Teacher surveys (e.g., BASC-3, BRIEF-2, ADHD-RS-5 or Vanderbilt, CARS-2, GARS-3, SRS-2, MCHAT or others)

**Time\*** - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of this testing package:

3 - 4 hours testing

Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed) 1-hour feedback session

**Cost for Ages 1 - 5: \$1,995\***

**Cost for Ages 6+: \$2350\***(More in-depth psychological testing can be added on at hourly rate).

**Full Psychological Evaluation:** This includes cognitive, emotional and personality testing, and provides in-depth information on an individual's functioning in all three of these areas. It's useful to help understand what a person is thinking and feeling as well as one's underlying personality structure, cognitive strengths and limitations, coping skills and weaknesses, and motivations behind behavior. In clinically complex cases and/or cases in which it is difficult for someone to identify the problem or articulate one's own experiences, a full psychological evaluation can be an invaluable resource for providing diagnostic clarification and treatment recommendations. Trauma, substance abuse, autism, and others assessments are not included, but can be added on (see evaluation menu).

**Tests:** IQ/ Cognitive Assessment (WISC or WAIS depending on age)

Child interview/ Self-Report Surveys (e.g., MMPI-A, MMPI-2, or BASC-3)/ Play-based assessment (age dependent)

Parent & Teacher surveys (e.g., BASC-3, BRIEF-2, ADHD-RS-5 or Vanderbilt)

**Time\*** - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of this testing package:

4 - 6 hours testing (typically divided into 2 sessions)

Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed) 1-hour feedback session

**Cost: \$2550**

**Abbreviated Psychological Evaluation:** This includes emotional and personality testing, and provides in-depth information regarding an individual's functioning in both of these areas. This testing helps understand what a person is thinking and feeling, his underlying personality structure, coping skills and weakness, and why a person behaves as he does. If previous cognitive testing exists, or if it seems fairly certain that cognitive limitations do not bear on the case, an abbreviated psychological evaluation can be an invaluable resource for providing diagnostic clarification and treatment recommendations.

**Tests:** Emotional and personality testing (e.g., MMPI-A or MPPI-2)

Client interview

**Time\*** - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of this testing package:

2 - 3 hours testing (sometimes divided into two sessions)

Up to 1 hour for document review/collateral interviews (additional fees apply if more time is needed) 1.5-hour feedback session

**Cost: \$1,995**

**Other Psychological Evaluation:** In some instances, a single or minimum number of tests, such as one personality test, or depression and anxiety screens, may be quite useful in clarifying the diagnosis and thus aiding in treatment planning.

**Tests:** Personality testing, depression screening, anxiety screening, etc.

**Time:** To Be Determined

**Cost:** Clinician's hourly fee (ranging from \$190 - \$265) for testing time, scoring, and interpreting the data

**Substance Abuse Evaluation:** Ages 11+. Our Substance Abuse testing package aims to provide an in-depth evaluation of an individual's current functioning when substance abuse, dependence, or intoxication is suspected or implicated. Featuring a comprehensive examination of an individual's background history and patterns of interpersonal, social, and emotional conflicts and stressors, this testing battery generates a focused assessment of underlying factors contributing to a person's pattern of substance use. Findings are integrated into a final report aimed at specifying effective treatment recommendations (i.e. evidenced-based treatment programs, referrals for treatment facilities, etc.) and informative resources tailored to an individual's presenting problems.

**Tests: Client interview**

**Self-Report Substance Abuse Surveys (e.g., Substance Abuse Subtle Screening Inventory /SASSI or SASSI A)**

**Personality + Emotional Functioning testing (e.g., M-PACI, MMPI-A, or MMPI-2; URICA, BAI, BDI, or OCC)**

**Time\* - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of the testing package:**

**3 - 4 hours testing**

**1-hour feedback session**

**review of materials and/or collateral interviews (up to 1 hour)**

**Cost: \$1875. As needed can be upgraded to assess cognitive, memory and other areas of concern for additional fees.**

**Psychosexual Evaluation:** Ages 4-17. When there is concern that a child or adolescent may have engaged, observed, or exhibited sexually inappropriate or sexually aggressive behavior, then a psychosexual evaluation may be warranted. Psychosexual evaluations assess the extent and severity of a child's sexual issue, provide recommendations for the type of treatment the child should receive to address his/her sexual difficulties, and provide recommendations for how a caretaker can implement a safety plan. **NOTE:** The evaluators can never assess guilt or innocence regarding a sexual offense. Currently, the evaluators are not able to perform court-ordered evaluations or in anticipation of court action. Please see the forensic/court-involved evaluations section for a list of services.

**Tests: IQ/ Cognitive Assessment (WPPSI, WISC, or WAIS depending on age)**

**Parent Interview**

**Client Interview (including a sexual specific interview)**

**Parent Surveys (e.g., emotional/ behavioral and/ or sexual-specific questionnaires, depending on age) Self-report Surveys (e.g., personality, emotional, behavioral questionnaires)**

**Relevant record review (e.g., victim's statement, police report, court or therapy records, past evaluations, etc.)**

**Collateral interviews**

**Time\*: 30m-1hr additional parent interview**

**4 hours with child/teen (split over two sessions)**

**1-hour relevant record review and collateral interviews. Additional fees apply if more time is needed. 1-hour feedback session**

**Cost: \$1995.**

**School Crisis Assessment Screening:** This brief assessment is helpful when there are concerns about a student's ability to return to classes when there are safety concerns (risk of self-harm or violence). The screening can also be used to help determine if a more in-depth risk assessment is warranted. Recommendations may be made for additional services, if needed. A written summary of the findings and recommendations can be provided to school staff with proper signed releases.

**Tests: Client interview, Record Review/ Collateral Interviews**

**Time\* - In addition to the 1 hr separate parent or adult client interview conducted prior to the selection of this testing package:**

**1 hour-client interview (separate)**

**1 hour record review/ collateral interview**

**30-minute write-up for summary (additional fees apply if more time is needed)**

**Cost: Fees per hour will be charged at the provider's regular rate. Please note more in-depth risk-assessments are available**

**Pre-Adoption Evaluation:** For couples who are preparing to adopt a child through the international adoption process. This pre-adoption evaluation includes a comprehensive interview to include a complete history of each parent. Additionally, there will be a joint parent interview, where a comprehensive history of the couple's relationship, plans for parenting, and understanding of the factors that will be important in parenting their potential child will be obtained. Additionally, parents will be administered a personality measure and self-report scales.

**Tests:** MMPI-2, Self-report surveys (e.g BDI, BAI, LEC-5)

**Time\*** - In addition to the 1 hr separate joint parent interview conducted prior to the selection of this testing package:

1-hour interview with each parent

2-3 hours of testing

Up to 1 hour of document review (e.g., countries' requirements for evaluations, home-study evaluation)

**Cost:** \$1750 per parent, additional hourly fees would apply for additional review of docs or testing required by your agency.

## Forensic and Court Ordered-Evaluations

**Child Custody Evaluation:** A comprehensive evaluation of each parent/legal guardians' household with detailed recommendations and parenting plan that speaks to the best interest of the child.

**Tests:** Standard package includes interviews with parents/legal guardians, interviews with children, psychological testing for parents, parent-child observations, collateral interviews, review of materials.

**Time:** Varies by package. Standard packages include:

Up to 9 hours (face-to-face)

Up to 2 hours (collateral interviews)

Up to 6 hours (record review)

**Cost:** Varies by package. Standard package is \$9,995. Additional charges may apply. To see a full description of our child custody evaluation services and packages, [click here](#) or ask us to send you the *Forensic Services* form.

**Parental Capacity Evaluation:** A comprehensive evaluation of a parent/legal guardian based on specific referral questions about the parent/legal guardian's ability to care for their child. This evaluation may be used to evaluate a parent's likelihood or risk for abuse or neglect. It may also assess the impact a parent/legal guardian's substance use or other mental health concerns may have on that parent/legal guardian's ability to care for their children. A comprehensive report including recommendations specific to parenting will be offered.

**Tests:** Interview with parent, review of records, psychological testing (rating scales to assess mood, parenting stress and engagement, assessment of traumatic life events, personality testing/measures), collateral interviews and review of records.

**Time:** Parent/clinical interview (up to 2 hours), psychological testing (up to 4 hours), and document review and/or collateral interviews (up to 2 hours)

**Cost:** \$2,850. Additional hourly charges may apply for communications with attorneys, additional review of materials, or contact with collateral sources.

**NOTE:** An evaluation of cognitive functioning can be added to this assessment for \$475 and a substance use evaluation can be added for a fee of \$350.

**Capacity to Proceed Evaluation:** Ages 18 and up. This evaluation package may be used to provide relevant information to the court about individual characteristics that may impact defendants' ability to understand the nature of the proceedings against them and rationally/reasonably assist in their own defense.

**Tests:** Background Interview, assessment of capacity to proceed (may include psychological testing), mental status exam.

**Time:** 10 hours including, mental status exam, background interview and assessment of capacity to proceed, review of records, psychological testing, and report writing.

**Cost:** \$2850.

**Court-Involved (or Ordered) Psychological Evaluation:** This comprehensive psychological evaluation includes emotional and personality testing and provides in-depth information regarding an individual's functioning in both areas. This evaluation can be an invaluable resource for providing diagnostic clarification and treatment recommendations. This evaluation is often used when a psychological evaluation has been ordered as part of a custody or forensic hearing.

**Tests:** Clinical interview, personality/psychological testing, rating scales to assess for mood and traumatic life experiences, collateral interviews, and review of material.

**Time:** Clinical interview (up to 1.5 hours), psychological testing (up to 3 hours), review of materials and/or collateral interviews (up to 1 hour).

**Cost:** \$2650. Additional hourly charges may apply for communications with attorneys, additional review of materials or contact with collateral sources.

**NOTE:** A brief parenting assessment may be added for \$325. This includes an additional 30 minutes of interview time, 1 hour for assessment, and 30 minutes of collateral interviews and/or record review. This add/on feature applies if a parent wishes to have brief information included about their parental engagement. For a more in-depth evaluation of a parent's capacity or functioning, as ordered by the court, please review the parental capacity evaluation.

**Court-Involved Substance Abuse Evaluation:** Ages 11+. Our Substance Abuse testing package aims to provide an in-depth evaluation of an individual's current functioning when substance abuse, dependence, or intoxication is suspected or implicated. Featuring a comprehensive examination of an individual's background history and patterns of interpersonal, social, and emotional conflicts and stressors, this testing battery generates a focused assessment of underlying factors contributing to a person's pattern of substance use. Findings are integrated into a final report aimed at specifying effective treatment recommendations (i.e. evidenced-based treatment programs, referrals for treatment facilities, etc.) and informative resources tailored to an individual's presenting problems.

**Tests:** Client interview

Self-Report Substance Abuse Surveys (e.g., Substance Abuse Subtle Screening Inventory/ SASSI or SASSI A)

Personality and Emotional measures as needed.

**Time:** 1-hour parent/clinical interview, 3-4 hours testing, 1.5-hour feedback session, review of materials and/or collateral, interviews (up to 1 hour).

**Cost:** \$2000. As needed can be upgraded to assess cognitive, memory and other areas of concern for additional fees.

**Risk Assessment:** Ages 18 and up. This evaluation package may be used to answer referral questions about an individual's likelihood of engaging in future acts of violence or criminal behavior (e.g., determining future risk of engaging in sexual offenses). It may also be used to assist triers of fact in determining the appropriate sentence, what conditions may be appropriate in the community settings to manage risk, and/or the appropriate level of detention/custody. Comprehensive report with specific recommendations will be provided upon completion of evaluative procedures.

**Tests:** Background Interview, assessment of future risk (may include psychological testing).

**Time:** 10 hours including, interview, document review, psychological testing, and collateral interviews (2 hours).

**Cost:** \$2675. Additional hourly charges may apply for communications with attorneys, additional review of materials or contact with collateral sources.

**Criminal Responsibility/Mental State at the time of Offense (MSO):** Ages 18 and up. This evaluation package may be used to provide relevant information to the court about defendants' mental state at the time of an offense.

**Tests:** Background Interview, assessment of MS (may include psychological testing), mental status exam. **Time:** Package include 10 hours including, mental status exam, background interview and assessment of capacity to proceed, review of records, psychological testing, and report writing.

**Cost:** \$2850. If appropriate, you may combine the Capacity to Proceed and MSO for an additional \$550, making the total price for both evaluations \$3300. Speak to a WFP professional before making any payments or deposits to determine if this pairing is appropriate.

**Expert Testimony/Case Consultation Services:** WFP professionals are available to provide expert testimony or consult with attorneys. Hourly rates will apply.

**Additional Important Information:** • The hourly rate for forensic evaluation services, outside of the package prices, is \$350 for all forensic examiners except Senior Psychologists whose hourly rate is \$450 per hour. WFP accepts IDS funding.

- Additional charges may accrue for collateral interviews, record review, and time spent in communication with the examinee and/or attorneys.
- Generally, reports will be provided 3-4 weeks following the completion of the evaluative procedures. Additional time will be required for completion of the report, if material is provided by any party after the cutoff date as provided by the evaluator for receiving those materials. -
- The evaluation packages listed above do not include fees for court or court-related appearance. Court fees are \$350/hour with a minimum retainer of at least \$1785 prior to the scheduled appearance. (Senior Psychologist court fees are \$450/hour with a minimum retainer of \$2250). - A 50% deposit is required before scheduling a testing appointment. Most testing follows a one hour initial intake appointment, separate from testing, after which parent/ client determines if they would like to move forward with the recommended test package. There are no refunds for any reasons.
